

RESOLUTION # 1, AMENDMENT #1

WHEREAS, the \$1.2 Trillion “Infrastructure” bill was passed by the US Senate on August 10, 2021, this bill adds an estimated \$250 Billion to the debt burden of the children of the state of Kentucky and of the rest of the United States and has been described by Republican Senator Bill Hagerty as a “smoke-screen to distract from the \$3.5 Trillion tax-and-spend spree from the democrats...”

AND, WHEREAS Senator Mitch McConnell on May 19, 2022 voted to pass a measure to send \$40 Billion to Ukraine, when the American people are currently suffering under a record high inflation, record high gas prices, dilapidated infrastructure, schools in need of security overhaul, and much more.
