Business Meeting Minutes: Monday August 8, 2022

Officers present: Chair Cheryl Benitez, Vice Chair Jim Weise, Treasurer Julia DuPlessis, and Secretary Rebecca Owens.

Meeting called to order by Chair Cheryl Benitez at 6:01 p.m. Charles White gave the invocation. Charles was appointed official Chaplain of the Hardin County GOP. Members and guests sang the National Anthem followed by reciting the Pledge of Allegiance.

Bobbie Coleman made a motion to amend the agenda to add and talk about censuring Senator Mitch McConnell. Motion seconded and passed. This item was added.

After review of the June Business Meeting Minutes, motion made and seconded to accept minutes. (No business meeting held in July due to staffing Hardin County GOP Booth at the Hardin County Fair).

Julia DuPlessis gave Treasurer's Report. **Beginning balance as of July 1, 2022: \$25,709.38.** Deposits included only one deposit (donation from Scott Kennedy) \$100.00. **Total Deposits: \$100.00.** Disbursements included: Red Dot Storage for July 2022 (1 year plus a free month) \$3,024.00, Radcliff Cultural Festival \$50.00, West Point River Festival \$40.00, and Glendale Crossing Festival \$100.00. **Total Disbursements: \$3,214.00. Balance as of July 31, 2022: \$22,595.38.**

The Budget Committee was created after the discussion of need in the June meeting. Budget Committee members include the following: Jim Weise, Marsha Jewell, Bobbie Coleman, Donna (Donnie) Thomas, and Julia DuPlessis. They met to discuss and plan the budget for timeframe of July 1, 2022, through December 31, 2022. See Budget Committee Report handout. The Float Storage amount of \$233.00 increased to \$252.00 per month due to price change in July by Red Dot Storage. Other budget items included: Meeting Room (600.00), Liability Insurance (1,000.00), and Donations to Candidates (\$5,000.00).

New Business: Donation to Candidates. A very lengthy discussion ensued concerning the monetary donation amounts to award. Initially the Budget Committee proposed donations to the candidates be approximately 20% (\$5000.00). Recommendations were made by Cheryl for the experienced and inexperienced candidates that voiced great need and for those facing strong opposition in the total amount of \$7000.00. Some candidates did not request financial contribution when asked. Discussion continued and motions were frequently amended to increase varied individuals' amounts. The maximum amount that the Hardin County Republican Party can donate to candidates is \$2,000.00 each. The Budget Committee initially planned to donate \$500.00 to each candidate. Amended motions to increase the amounts for two of the three county positions passed. So, to increase the amount for the third county position, Lance Turlington pledged to donate \$21.00 monthly for the next 48 months to the Hardin County GOP. After asking for two more volunteers to pledge to do the same (Charles White and Jim Weise agreed to pledge), all three county candidates will receive \$2000.00, and it does not cost the Budget Committee any additional amount above the currently proposed \$1000.00 for each. The final amended motion was made, seconded, and unanimously passed that each of the following candidates receive a maximum amount of \$2000.00: Steve Bratcher, Brian D. Smith, Willie Oden, Rob Reynolds, and each of the following magistrate candidates receive \$500.00: T.W. Shortt, Patsy Whitehead, E.G. Thompson, and Kenny Muse. The total amount donated to our candidates will be \$10,000.00.

Recognition of Candidates: Shawn Marie Alcott (candidate for Kentucky Supreme Court) was present and spoke to the group. She is a lawyer and has an office in Elizabethtown and Bowling Green. Her brother-in-law is mayor of Bowling Green. Rob Reynolds for Hardin County Jailer spoke to the group and encouraged volunteers to get out there and pound the pavement. He wanted everyone to be aware of Planned Parenthood and their campaign, and the abortion issue will be on the ballot in November. He also shared information about current jail problems regarding escapes and injuries. Matt Deneen for State Senator 10th District was present. Raymond Eric Carr for Circuit Court Judge (Nonpartisan) was present (Jim Weise spoke on behalf of Eric earlier. "Eric has worked hard and has common sense. To ensure we do not violate any RPK rules, the officers will appeal the censure in accordance with paragraph 12.04 Appeals and Contest and subparagraph (a) of the Official Rules of the Republican Party of Kentucky. The purpose of the county committee is to uphold and support our candidates and nothing more. It is our opinion that the censure will encourage democrats and discourage republicans. Including those who have financed our party in many ways such as Dr. Larry Hall who provided our headquarters venue at no cost to the GOP. For your information, the headquarters will no longer be open after December 5th. Thank you to those who came and worked at the headquarters.

Our party funds cannot pay for any censure ad in the newspaper. Funds are used only to support GOP candidates or for opposition of their opponents.

There will be no December business meeting. Everything that needed to be discussed took place at our November 14th business meeting and at the special meeting on November 29th. The rules state that we must meet once a quarter and I shall let you know the date of our next meeting.

We the undersigned officers of the Hardin County Republican Party, in accordance with Rule 12.04. Appeals and Contests, subparagraph (a) of the Official Rules of the Republican Party of Kentucky, appeal an action to censure Senator Mitch McConnell voted on and approved by the majority of the precinct officers (24-14) of the Hardin County Republican Party.

The initial idea of censuring Senator McConnell came as a surprise to the leadership and passed with a majority (18-6) vote on August 8, 2022, but there was no specific verbiage of the censure until a special meeting to consider the censure was held on Tuesday, November 29, 2022. Attached you will find a copy of the censure which passed with a majority vote on that date. It should be noted that no Hardin County Republican Party officer, elected official, or former candidate voted for the censure.

The undersigned officers question the propriety of the censure action in toto. While we do not question anyone's First Amendment rights to say what they want, we do question the authority of any county party to act outside the scope of Rule 4. County Committees of the Official Rules of the Republican Party of Kentucky. The mandate of RPK and all local parties is clear--to recruit Republican candidates and to work for the election of Republican candidates. We do not believe it is within the purview of any local party to censure any elected Republican official. While an individual Republican or a group of Republicans or other citizens may complain publicly or privately about any candidate or elected official, it is our firm belief that a censure issued by a county party is null and void because issuing a censure is ultra vires or outside the authority of any county party.

Under the rules we are appealing the decision of the Hardin County Republican Party to censure Senator Mitch McConnell based on it is outside the scope of Rule 4.0 County Committees and the duties of the county and precinct officers. In addition, we request that the 2nd District Committee issue a cease-and-desist order on any and all actions including but not limited to print, social media or telecommunication pending the outcome of the appeal process.

- **3.04 Meetings:** Notice of each meeting will be given in writing by regular or electronic means by the District Secretary at least five (5) business days before the meeting. The District Committee may be called into a special meeting with twenty-four (24) hours electronic notice by the District Chairman, 25% of the District Committee, or by the State Chairman. Meetings may be conducted telephonically, by video conferencing or by other mechanisms as authorized by the RSCC Executive Committee. Electronic voting and balloting are permitted.
- **3.05** Appeals: The process for appeals related to matters arising from the District Committee or any decision that is ruled upon by the District Committee shall be governed according to the provisions of Rule 12.04.
- 4. COUNTY COMMITTEES: The County Committee's authority shall include the managing and directing of Party affairs in their respective county including the collection and disbursement of Party funds; the promotion of campaigns of Republican candidates who represent their county at the national, state and local levels and the recruitment of poll workers that will represent the Republican Party on Election Day and ensure the fairness of elections. Each County Party will submit an annual statement of their Party goals for the coming year and a summary of their revenue and expenses for the current year just ended and for the projected year by July 31st to the District Committee and the RSCC budget committee.
- **4.01. Membership:** The membership of each County Committee shall consist of the Precinct Officers and the County Officers. Each County Committee or Executive Committee (pursuant to Rule 4.08) may, by a two-thirds vote in the affirmative, include as members any or all elected Republican officials who reside in the county, provided that quorum for such meetings shall be two-fifths.

In addition to Precinct Committees, County Committees may, by a majority vote, establish Ward, District or Area Captains over groups of Precincts in that County. Such Captains will be full-voting members of the County Committee.

4.02. Officers: The County Officers shall be:

- (a) County Chairman: The County Chairman, or their designee, serves as the Chief Executive Officer of the County Party with all necessary and implied powers to carry out his/her duties. He/she is charged with overseeing an annual plan that is reflective of the County goals, priorities and financial resources; Oversees the overall structure of the County party and coordination of County Party activities. As the primary officer, the County Chairman is responsible to ensure the scope of the County Committee tasks is accomplished. The County Chairman shall preside at all County meetings, shall create and appoint any special committees as necessary, and shall serve as an exofficio member of all special and standing County committees. The County Chairman is responsible for carrying out the mandate of the Rules.
- (b) County Vice-Chairman: The County Vice Chairman shall have all the duties and authorities of the County Chairman during the absence or disability of the County Chairman, and who shall also serve during a vacancy in the office of County Chairman until such vacancy is filled. Further, the Vice Chairman, or their designee, is to assist and support the Chairman in carrying out important tasks and act as a go-between for the Chairman and other key stakeholders as needed. While this is one of the most undefined roles, it plays a critical role in maintaining the relationship between the State, and District.



composition of the RSCC. Further, any change of rules made by the Executive Committee must be submitted for ratification by the RSCC at the next meeting thereof; provided, however, that any changes made by the Executive Committee shall have the full force and effect as the Rules of the RSCC until such time as they fail to receive said ratification.

- **12.04. Appeals and Contest:** Any dispute over the identity of an officer, outcome or validity of any election, or matter pertaining to the Rules and procedure of any Precinct Committee, County Committee, or District Committee shall be resolved in accordance with the following dispute resolution procedure:
 - (a) Notification of Appeal: Any party to such a dispute may initiate proceedings under this Section by filing a written complaint with the Chairman of the committee for which the appeal shall arise—that is, (i) if the appeal arises from City, Precinct, Magisterial District and County matters shall be ruled upon by the County Committee; provided, however, the losing party may appeal for a hearing to a special Republican Congressional District committee (ii) if the appeal arises from the Precinct Committee, County Committee, or the County Chair, the appeal is first made to the District Chair and District Committee, however, the losing party may appeal for a hearing, due to questions of interpretation of the rules or procedure, by notifying the State Chair for review by the Membership Committee. Any such complaint must be delivered to the appropriate Chairman by electronic mail and time stamped no later than seven (7) business days following the incident, election, or other event from which the dispute arises.
 - (b) Committee Composition: Both the County Special Committee and District Special Committee will be made up of the respective body's officers, namely the Chairman, Vice Chairman, Secretary, Youth Chairman and Treasurer shall comprise the said special County/District committee. In the event that any officer cannot or will not serve, the District Chairman shall appoint a replacement member for the hearing.
 - (c) Appeal at the County and/or District level: Not later than three (3) business days following the receipt of any complaint filed in accordance with Rule 7.02, the Chairman of the Committee in which the dispute arises shall notify the committee of jurisdiction; that is, if the dispute arises from the Precinct or County Committee, the County Chair shall notify the County committee, and if such dispute arises between counties within the same Congressional District or regarding the identity of an officer or procedure at the Congressional District level, then the District Chairman shall notify the District Officers. The County Committee shall hear all appeals that originate at the precinct or county level and shall, within thirty (30) business days of the receipt of such appeal, hear the matter and vote on a resolution.
 - (d) Hearings by the Special Appeal Committee: At any hearing held all parties to the dispute may be permitted to appear before the Committee and present evidence, including oral and written testimony, in accordance with procedures approved by a majority of the members of the Committee. The entire hearing record shall be made available to any member of the Committee no later than thirty (30) business days following a request in writing thereof to the Chair of the Committee. The Secretary shall record the minutes of any such meeting and make them available to the members of the committee and the State Secretary within thirty (30) business days of such proceedings.
 - (e) Further Appeal: Any Party may appeal a decision of the County or District Committee, in whole or in part, by filing a written appeal with the State Chairman, who shall refer the matter to the District Chair of the District the County in a part.
